**01:15 PM** – James Bell sends email to Lea Bickerton at [REDACTED] [HERE](#)

          Informs her, Lea Bickerton, that he, James Bell, has no idea what is going on with the case that he, James Bell, hired her, Lea Bickerton, to represent him, James Bell, in back on September 18, 2017. He, James Bell, informs her, Lea Bickerton, that he, James Bell, was going to file a formal complaint with *The Disciplinary Board of the Supreme Court of Pennsylvania* if he, James Bell, did not receive written proof of what she, Lea Bickerton, did and the outcome of the case that she, Lea Bickerton, was hired to represent him, James Bell, in within three (3) business days.

**10:15 PM** – James Bell arrested in his home at 4566 [REDACTED ADDRESS], PGH, PA 15224-1514 by Allegheny County Sheriffs [HERE](#)

          At 10:15 PM, James Bell hears two clusters of loud knocks on his, James Bell's, front door of his, James Bell's, home at 4566 [REDACTED ADDRESS].. Pittsburgh, PA 15224-1514. He, James Bell, answers the door to find approximately 4 (four) Allegheny County Sheriffs standing there. He, James Bell, without being asked, let's the Allegheny County Sheriffs into his, James Bell's, home where he, James Bell, is immediately placed in handcuffs and allegedly not read his, James Bell's, Miranda Rights, of which are not heard being read to him, James Bell, by the Allegheny County Sheriff that was placing him, James Bell, in handcuffs in the security video clip of the security camera that was/is placed in between his, James Bell's, front door and screen door. What is heard in that said security video clip are other questions being asked by the Allegheny County Sheriff that was placing him, James Bell, in handcuffs. James Bell requests to log off of his laptop because he, James Bell, was logged in to his work and that request was responded with "that's not going to happen" by the Allegheny County Sheriff that placed him, James Bell, in handcuffs. James Bell then requests to retrieve his, James Bell's, wallet and keys and that request was met with mixed responses. The Allegheny County Sheriff that placed the handcuffs on him, James Bell, responded with a "no" while the Allegheny County Sheriff that took him, James Bell, by the arm from the front responded with "we'll get your key", as heard in the security video clip. James Bell then voiced concern for his dog, Roxie, and that no one would be able to get in to care for her, Roxie, without his, James Bell's, keys or his, James Bell's, finger because the deadbolt unlocked via his, James Bell's, fingerprint. The Allegheny County Sheriff that placed him, James Bell, stated that he was only going to be at the Allegheny County Jail for 3-4 (three to four) hours.

**10:18 PM** – James Bell is led out of his home by two (2) Allegheny County Sheriffs

          As seen in the security video clip, James Bell is led out of his, James Bell's, home by one (1) Allegheny County Sheriff from the back and another Allegheny County Sheriff

takes him, James Bell, by the arm from the front. It is also seen in the security video clip that he, James Bell, is being questioned by the Allegheny County Sheriff that takes him, James Bell, by the arm from the front as he, James Bell, is being escorted out of his, James Bell's, home. James Bell is then patted down for a second time by the Allegheny County Sheriff that took him, James Bell, by the arm in the front. James Bell is questioned more then escorted to a dark colored van by another Allegheny County Sheriff and placed inside and seat belted in. The journey to the Allegheny County Jail began.

**10:15 PM** – James Bell walks through his, James Bell, back door to his home at 4566 [REDACTED ADDRESS] (Choate Way) Pittsburgh, PA 15224-1514. [HERE](#) EXACTLY 24 hours from the 2 (two) clusters of loud knocks he, James Bell, heard on his front door of his home at 4566 [REDACTED ADDRESS], Pittsburgh, PA 15224-1514. James Bell's dog, Roxie, had been home for exactly 24 hours alone without any water or food. He, James Bell, did not recall until inside the Allegheny County Jail that he, James Bell, had washed Roxie's water fountain and had placed it to the side to air dry not long before the arrest of James Bell. James Bell also made the observation, while in holding at the Allegheny County Jail, that almost every other prisoner inside each holding cell that he, James Bell, was placed in, he, James Bell, recognized from somewhere. James Bell also made the observation that there were not many other prisoners there when he, James Bell, arrived or came in throughout his, James Bell's, stay yet it still took exactly 24 hours for him, James Bell, to arrive home after being arrested.

**NOT LONG AFTER** – James Bell checks his, James Bell's, email. Upon checking his, James Bell's, email on 12/15/2023, he, James Bell, see's an email from Lea Bickerton, 2 (two) actually. James Bell clicks on and opens the first in the list to find a blank response to the email that he, James Bell, sent to Lea Bickerton back on January 29, 2023. [HERE](#) The response from Lea Bickerton is dated Friday December 15, 2023 at 10:37 AM. The second email that he, James Bell, opens from Lea Bickerton is dated Friday December 15, 2023 at 10:36 AM. [HERE](#) The email contains 8 (eight) attachments that Lea Bickerton claims were sent to him, James Bell, previously. 1 (one) of the attachments was the only one that had been sent to James Bell previously.
